TRADEMARK ASSIGNMENT

THIS Agreement is between Marc Turtletaub ("Turtletaub"), an individual, and BBIP 2019, LLC ("Assignee"), a limited liability company of Delaware, having a place of business at 1880 Century Park East, Suite 1600, Los Angeles, CA 80087, U.S.A. Collectively, the foregoing are referred to as the "Parties" or singularly as a "Party."

WHEREAS, Turtletaub owns the marks identified in Schedule A, including but not limited to applications for registration and registrations, and the goodwill associated with all the foregoing (collectively the "Marks");

WHEREAS, Assignee wants to acquire all global rights and licenses, if any, in the Marks from Turtletaub; and

WHEREAS, Turtletaub wants to transfer all global rights and licenses, if any, in the Marks, to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and exchange of which is hereby acknowledged, the Parties agree as follows:

1. Turtletaub hereby assigns to Assignee all its global right, title and interest in and to the Marks listed in Schedule A including but not limited to, for the avoidance of doubt, all the goodwill embodied in the Marks, and the applications and registrations. It is the intention of the Parties that all right, title and interest acquired by Assignee shall include all rights enjoyed by Turtletaub prior to the assignment herein.

2. This Agreement includes the assignment to Assignee of the rights to sue, recover and obtain damages for any illegal activity perpetrated upon the Marks, the goodwill of the Marks, or recoverable by Turtletaub in association with such illegal activity, notwithstanding the date such activity may have occurred, the foregoing to the fullest extent as would have been held by Turtletaub if no assignment were made. This Agreement also includes the assignment to Assignee of all liabilities arising from the ownership, registration or use including but not limited to tortious conduct of the Marks, notwithstanding the date such activity may have occurred, to the fullest extent as would have been held by Turtletaub if no assignment were made.


3. The Parties acknowledge the business considerations giving rise to the consideration for the assignment herein.

4. Turtletaub agrees to cooperate as reasonably necessary with Assignee at Assignee's expense in executing documents necessary to perfect this assignment and assure its recordation with any governmental authority.


5. This Agreement shall be governed by the laws of the State of Delaware, United States of America. The Parties expressly consent to subject matter and personal jurisdiction of the state and federal courts of the State of Delaware in connection with any dispute arising out of this agreement, and that the State of Delaware is an appropriate and convenient venues for the resolution of any such dispute.

6. This Agreement shall be construed in accordance with its terms and without regard to the drafter of any provision hereof. The Parties acknowledge that they have had ample opportunity to consult with counsel of their choosing and that if they failed to so consult, such was an election freely made by them. The Parties acknowledge that authorized representatives have executed this Agreement on their behalf.
