## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS is executed as of April 22, 2019 by **WELLS FARGO BANK, NATIONAL ASSOCIATION** (“Wells Fargo”), as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, “Agent”). Any capitalized term not otherwise defined herein shall have the meaning ascribed to it in the Trademark Agreement (as defined below).

WHEREAS, **PLANSOURCE HOLDINGS, INC.**, a Delaware corporation (“Holdings”), and **PLANSOURCE BENEFITS ADMINISTRATION, INC.**, a Florida corporation (“PlanSource” and together with Holdings are referred to hereinafter each individually as a “Grantor”, and individually and collectively, jointly and severally, as the “Grantors”), entered into that certain Trademark Security Agreement, dated as of September 16, 2016 (the “Trademark Agreement”) with the Agent.

WHEREAS, pursuant to the Trademark Agreement, the Grantors granted to the Agent, as security for the Obligations, a continuing security interest in all of the Grantors’ right, title and interest in and to certain trademarks (collectively, the “Trademark Collateral”);

WHEREAS, certain other security interests in trademarks were recorded in the Trademark Division of the United States Patent and Trademark Office on September 16, 2016, at Reel 5878 and Frame 0786; and

WHEREAS, the Grantors has requested that the Agent release the liens and security interests granted to the Agent by the Grantors with respect to the Trademark Collateral, including but not limited to those trademarks listed on Exhibit A attached hereto.

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

(a) releases the liens and security interests granted by the Grantors to the Agent pursuant to any security agreement (including but not limited to the Trademark Agreement) in and to the Trademark Collateral; and


(b) to the extent the Agent shall be deemed to have any right, title or interest in the Trademark Collateral, retransfers and reassigns, without representation, warranty or recourse, to the Grantor all of such right, title and interest solely with respect to the Trademark Collateral.

This Release of Security Interests in Trademarks shall be governed by the laws of the State of New York.
