**TERMINATION AND RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARKS**

February 18, 2019

WHEREAS, Owensboro Speciality Polymers, Inc. (the "Company") entered into (i) the Guarantee and Collateral Agreement, dated as of January 13, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), among Borchers Americas Inc. (as successor by merger to Borchers Inc.) (f/k/a OMG Americas, Inc.), Borchers Group Limited LLC, a Delaware limited liability company ("TopCo"), the Subsidiaries of TopCo identified therein from time to time, and BMO Harris Bank N.A., as the Administrative Agent for the Secured Parties (in such capacity, the "Administrative Agent"), and (ii) the Intellectual Property Security Agreement dated as of November 1, 2017 (the "IP Security Agreement", and together with the Guarantee and Collateral Agreement, the "Agreements") between the Company in favor of the Administrative Agent, pursuant to which the Company granted a security interest (the "Security Interest") in all of the Company's right, title and interest in and to the Trademarks (as defined in the Guarantee and Collateral Agreement), including certain trademark registrations and trademark applications set forth on the attached Schedule A (the "Specified Trademarks"), all to the extent set forth in the Agreements; and

WHEREAS, the Administrative Agent has agreed to release the Security Interest in the Specified Trademarks.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, without warranty or recourse of any kind; hereby releases its Security Interest held in the Specified Trademarks and hereby (i) terminates all its rights, powers, privileges and remedies under the Agreements with respect to the Specified Trademarks, (ii) re-conveys, re-transfers and sets over to the Company any right, title or interest that the Administrative Agent may have acquired in the Specified Trademarks, together with all the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Specified Trademarks.
