INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “*Agreement*”) is executed on March 29, 2019 (the “*Effective Date*”), by and among Charlotte Russe Holdings Corporation, a Delaware corporation (“*Seller Parent*”), each of the Subsidiaries of Seller Parent (together with Seller Parent, “*Sellers*,” and individually a “*Seller*”), and YM Inc. (Sales), a Canadian corporation (“*YM*”), and CR (2019) LLC, a Delaware limited liability company (“*CR 2019*” and collectively with YM, “*Purchaser*”). Capitalized terms not defined herein shall have the meaning ascribed to such terms in the Purchase Agreement (as defined below).

WHEREAS, Purchaser and Sellers are parties to that certain Asset Purchase Agreement, dated as of March 18, 2019 (as amended, restated, supplemented, modified or waived from time to time in accordance with its terms, the “*Purchase Agreement*”) pursuant to which Sellers shall sell, assign, transfer, convey and deliver the Purchased Intellectual Property to the Purchaser;

WHEREAS, the Purchaser and Sellers hereby enter into this Agreement evidencing the vesting in CR 2019, as designated by Purchaser, of all of the Purchased Intellectual Property created, established or registered in the United States, and the vesting in YM, as designated by Purchaser, of all of the Purchased Intellectual Property created, established or registered in Canada or any other jurisdiction outside of the United States, as set forth herein for the purpose of recording the sale, conveyance, assignment, transfer and delivery to the Purchaser of the Purchased Intellectual Property with any applicable Governmental Authority; and

WHEREAS, the execution and delivery of this Agreement is required in connection with the consummation of the transactions contemplated by the Purchase Agreement.

NOW, THEREFORE, in consideration of the premises and mutual agreements set forth in the Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Purchaser and Sellers hereby agree as follows:

1. **Assignment.** Effective as of 12:01 a.m. EDT on the date hereof, Sellers hereby irrevocably and unconditionally assign, transfer, convey and deliver to YM or CR 2019, as appropriate, to the fullest extent permitted by law, free and clear of liens, all right, title, and interest worldwide in and to the Intellectual Property included in the Purchased Intellectual Property including, without limitation:

- (a) the Transferred Copyrights listed on **Exhibit A**;
- (b) the Transferred Domain Names and Social Media Accounts listed on **Exhibit B**;
- (c) the Transferred Patents listed on **Exhibit C**;
- (d) the Transferred Trademarks listed on **Exhibit D** together with the goodwill associated with and symbolized by each such Transferred Trademark; and
- (e) all rights of any kind whatsoever of Sellers accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; and
- (f) any and all rights to the Purchased Intellectual Property included in the Purchased Assets.

2. **Authorization.** Sellers hereby authorize and request the Commissioner of Patents of the United States, the Commissioner of Trademarks of the United States, the Librarian of Congress of the United States and any other official of any applicable Governmental Authority worldwide and each registrar of a Domain Name or Web Site, to record all registrations and applications for registration included in such Intellectual Property included in the Purchased Intellectual Property in the name of YM or CR 2019, as appropriate, and issue any and all registrations from any and all applications for registration included in such Purchased Intellectual Property to and in the name of YM or CR 2019, as appropriate.

3. **Purchase Agreement Controls.** Nothing in this Agreement shall be deemed to supersede, enlarge or modify any of the provisions of the Purchase Agreement, all of which survive the execution and delivery of this Agreement as provided and subject to the limitations set forth in the Purchase Agreement. If any conflict exists between the terms of this Agreement and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and control.

4. **Further Assurances.** From time to time following the Effective Date, Sellers shall, at Purchaser's request and expense, execute and deliver such documents and other papers and perform any other actions as may be required to carry into effect and perfect the assignment and transfer in this Agreement or to enable Purchaser to obtain the full benefits of this Agreement. In the event Purchaser is unable for any reason, after reasonable effort, to secure any Seller's signature on any document needed in connection with the actions specified herein, such Seller hereby irrevocably designates and appoints Purchaser and its duly authorized officers and agents as its agent and attorney in fact, which appointment is coupled with an interest, to act for and in its behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of the assignment effected hereunder with the same legal force and effect as if executed by such Seller.

5. **Moral Rights.** Any assignment of copyright under this Agreement includes all rights of paternity, attribution, integrity, disclosure and withdrawal and any other rights that may be known as or referred to as *droit moral* or "moral rights" (collectively, "**Moral Rights**"). To the extent Moral Rights cannot be transferred or assigned under applicable law and to the extent allowed by applicable law, Sellers hereby waive all Moral Rights with respect to all copyrights and copyrightable works included in the Purchased Intellectual Property, and all uses thereof, and consents to any action of Purchaser that would violate such Moral Rights in the absence of such waiver or consent.

6. **Governing Law and Jurisdiction.** This Agreement and any action related thereto will be governed and interpreted by and under the laws of the State of Delaware, without giving effect to any conflicts of laws principles that require the application of the law of a different state. All disputes arising out of or related to this Agreement, including, without limitation, any dispute relating to the interpretation, meaning or effect of any provision hereof, will be resolved in the Bankruptcy Court and the parties hereto will each submit to the exclusive jurisdiction of the Bankruptcy Court for the purposes of adjudicating any such dispute, to the extent the jurisdiction of the Bankruptcy Court is applicable. If the jurisdiction of the Bankruptcy Court is not applicable, any legal action, suit or proceeding arising out of or relating to this Agreement, each and every agreement and instrument contemplated hereby or the transactions contemplated hereby and thereby shall be instituted in the United States District Court for the District of Delaware sitting in New Castle County.

7. **Miscellaneous.** This Agreement, together with the Purchase Agreement, constitutes the final, complete and exclusive agreement between the parties with respect to the subject matter hereof and supersedes all previous and contemporaneous proposals, arrangements or understandings made between the parties with respect to such subject matter. This Agreement may be modified or amended only by a written agreement executed by each party. Nothing in this Agreement, express or implied, is intended or shall be construed to confer upon, or give to, any Person other than Purchaser and its successors and assigns,


any remedy or claim under or by reason of this Agreement or any terms, covenants or condition set forth herein. This Agreement will be binding upon and inure to the benefit of each party and its successors and assigns. No party may assign any of its rights or delegate any of its obligations under this Agreement without the prior written consent of the other parties; any attempted assignment or delegation in violation of the foregoing will be null and void. No failure to exercise, and no delay in exercising, on the part of any party, any privilege, any power or any rights hereunder will operate as a waiver thereof, nor will any single or partial exercise of any right or power hereunder preclude further exercise of any other right hereunder. If any provision of this Agreement shall be adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable.

8. **Counterparts.** This Agreement may be executed in any number of counterparts and each such executed counterpart shall be deemed to be an original instrument, but all such executed counterparts together shall constitute one and the same instrument.


