RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of April 23, 2019, is made by ALLY BANK, in its capacity as administrative agent (in such capacity, "Administrative Agent") for itself and the Lenders from time to time party to the Loan and Security Agreement dated as of February 29, 2016, as amended from time to time (the "Loan Agreement").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 29, 2016 (the "Security Agreement"), Muth Mirror Systems, LLC ("Grantor") granted to Administrative Agent a security interest in certain Intellectual Property Collateral, including the Trademarks more fully identified on Schedule A annexed hereto and made a part hereof (collectively, the foregoing, the "Released Trademarks"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, the Security Agreement, and Administrative Agent's security interest in the Released Trademarks, was recorded with the United States Patent and Trademark Office ("USPTO") on February 29, 2016, at Reel 5742, Frame 0095.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, for itself and the lenders from time to time party to the Loan Agreement, and Grantor:

1. Administrative Agent hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges Administrative Agent's security interest in, lien on, and all other right, title and interest in and to the Released Trademarks (if any) granted to Administrative Agent pursuant to the Security Agreement and Administrative Agent hereby reassigns to Grantor any and all such right, title and interest (if any) that the Administrative Agent may have in the Released Trademarks, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such Released Trademark. Administrative Agent hereby authorizes the recordation of this Release with the USPTO.
2. This Release shall be governed by and construed in accordance with the laws of the state of New York, without regarding to conflicts of law or choice of law principles.
