## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 24, 2019 (this "Release") is made by U.S. Bank NATIONAL ASSOCIATION, as collateral agent on behalf of several banks and other financial institutions (in such capacity, the "Collateral Agent") in favor of WVLT-TV, Inc. (the "Grantor").

Pursuant to the Second Lien Collateral Agreement, dated as of April 29, 2010 entered into by the Grantor, each other grantor party thereto, and Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor, certain affiliates of Grantor, and Collateral Agent entered into a certain Second Lien Trademark Security Agreement, dated as of April 29, 2010 and recorded in the United States Patent and Trademark Office on May 03, 2010, at Reel 4197, Frame 0607 (the "Trademark Security Agreement"), and pursuant to the Security Agreement and Trademark Security Agreement, the Grantor pledged to the Collateral Agent for the benefit of the Secured Parties (as defined in the Security Agreement), and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under the Trademarks (as defined in the Security Agreement), including (without limitation) the foregoing identified on Schedule A hereto and incorporated herein by reference.

The Collateral Agent, on behalf of itself and the Secured Parties, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the grant and pledge in and all of its lien on and security interest in, all right, title and interest in, to and under the Trademarks granted under the Security Agreement and Trademark Security Agreement, including (without limitation) the foregoing identified on Schedule A hereto and incorporated herein by reference. Any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.


