## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (the "**Release**") is entered into this 24 day of April, 2019 (the "**Effective Date**"), by and from Texas Capital Bank, a national banking association on behalf of itself and its affiliates ("**Secured Party**"), with offices at 2000 McKinney Avenue, Suite 700, Dallas Texas 75201, to Versaflex, Inc., a Missouri corporation ("**Versaflex**"), Raven Lining Systems Inc., an Oklahoma corporation ("**Raven**"), Versaflex Acquisition Corp., a Delaware corporation ("**Acquisition**"), Milamar Coatings, L.L.C., an Oklahoma limited liability company ("**Milamar**" and together with Versaflex, Raven and Acquisition, collectively the "**Borrowers**"), Bridge Preservation LLC, a Missouri limited liability company ("**Bridge Guarantor**"), Sector Media Strategies, LLC, a Kansas limited liability company ("**Sector Guarantor**"), and Cohesant Inc., a Delaware corporation ("**Cohesant Guarantor**" and together with Bridge Guarantor, and Sector Guarantor, collectively the "**Guarantors**"; Borrowers and Guarantors are, collectively the "**Grantors**"), with offices at 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808.

WHEREAS, the Secured Party and Grantors are parties to that certain Intellectual Property Security Agreement dated as of March 30, 2017; that certain Intellectual Property Security Agreement dated December 31, 2017; and that certain Amended and Restated Intellectual Property Security Agreement dated as of September 13, 2018 (collectively referred to as the "**Intellectual Property Security Agreement**"; capitalized terms used but not defined herein have the meaning given such terms in the Intellectual Property Security Agreement), pursuant to which Grantors granted the Secured Party a security interest in various U.S. Patents (listed on Exhibit A, attached hereto) (the "**Patents**"), and various U.S. Trademarks (listed on Exhibit B, attached hereto) (the "**Trademarks**").

WHEREAS, the Intellectual Property Security Agreements were previously recorded with the United States Patent and Trademark Office on March 31, 2017 at Reel 041814 Frame 0929 and on September 17, 2018 at Reel 046889 Frame 0621, at Reel 046889 Frame 0701, and at Reel 046889 Frame 0854 as to the Patents; and on March 31, 2017 at Reel 006023 Frame 0859, on January 03, 2018 at Reel 006241 Frame 0861, and on September 17, 2018 at Reel 6439 Frame 0786, at Reel 00649 Frame 0799, and at Reel 006466 Frame 0384 as to the Trademarks.

WHEREAS, all amounts owing and due under the Credit Agreement have been paid in full, and the Secured Party wishes to evidence the release of its interest in the Intellectual Property Collateral, including, without limitation, the Patents and Trademarks, and retransfer and reassign to Grantors, without recourse, all of its right, title and interest in and to the Intellectual Property Collateral, including, without limitation, the listed Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. The Secured Party hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Intellectual Property Collateral, including, without limitation, the Patents listed in Exhibit A (attached hereto) and the Trademarks listed in Exhibit B (attached hereto), including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and

future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the Intellectual Property Collateral, including, without limitation, the listed Patents and Trademarks to their respective Grantors, without recourse. The Secured Party authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.

2. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic transmission (including .pdf file) shall be as effective as delivery of a signed counterpart of this Release.


