TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") is entered into as of the 28th day of February, 2019, by and between Halliburton Energy Services, Inc., a Delaware corporation ("Assignor"), and Landmark Graphics Corporation, a Delaware corporation ("Assignee").

RECITALS

WHEREAS, Assignor and Assignee are wholly-owned subsidiaries of Halliburton Company (the "Company"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns, transfers and conveys to Assignee all of its right, title and interest in and to the Trademark, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill of the business symbolized by the Trademark and the portion of business to which the Trademark pertains, and all common law rights and all registrations and pending and abandoned applications for the Trademark.

2. Further Assurances. The parties agree to take such further actions and execute and deliver such other documents, assignments, certificates, agreements and other instruments as may be necessary or desirable in order to consummate or implement this Assignment.

3. Binding Effect. This Assignment, and all the terms and provisions hereof, shall be binding upon and shall inure to the benefit of Assignor and Assignee, and their respective successors and assigns.
