RELEASE OF SECURITY INTEREST IN TRADEMARKS

March 21, 2019

WHEREAS, SCRIP HOLDING CORPORATION, a Delaware corporation ("Holdings"), SCRIP PRODUCTS CORPORATION, a Delaware corporation ("Scrip Products"), ADVANTAGE MEDICAL EQUIPMENT & SUPPLY, INC., an Indiana corporation ("Advantage Medical"), SCRIP, INC., an Illinois corporation ("Scrip Illinois"), and ALLEGRO ENTERPRISES, INC., an Arizona corporation ("Allegro Enterprises", and together with Holdings, Scrip Products, Advantage Medical and Scrip Illinois, individually each referred to herein as a "Grantor" and collectively referred to herein as "Grantors") entered into that certain Trademark Security Agreement, dated as of June 23, 2017, in favor of STIFEL BANK & TRUST, as administrative agent (the "Administrative Agent"), which was recorded with the United States Patent and Trademark Office at Reel/Frame 6091/0662 on June 27, 2017 (the "Agreement"). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement.

WHEREAS, pursuant to the Agreement, the Grantors granted to the Administrative Agent a security interest in all of the Grantors' right, title and interest in and to the Trademark Collateral, including the trademarks identified on Schedule A attached hereto (the "Trademark Security Interest");

WHEREAS, the Grantors request a release of the Trademark Security Interest; and

WHEREAS, the Administrative Agent desires to terminate and grant a release of the Trademark Security Interest as provided in this release.


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without representation, warranty or recourse, hereby (a) terminates the Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Security Interest in its entirety and (c) reassigns to the Grantors any and all right, title and interest of any nature whatsoever which it may hold in or to any of the Trademark Collateral (including without limitation, the trademarks identified on Schedule A attached hereto) and associated common law rights and goodwill appurtenant thereto, effective as of the date set forth above.

The Administrative Agent acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.


