RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated April 23, 2019, is made by **Silicon Valley Bank**, with an office at 3003 Tasman Drive, Santa Clara, California 95054 ("Agent"), in favor of **MacStadium, Inc.**, a Georgia corporation, with an office at 3525 Piedmont Road NE, Suite 700, Atlanta, Georgia 30305. Capitalized terms used but not defined herein shall have the meaning given to them in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement by and between Agent and Debtor, dated March 4, 2016, as the same may have from time to time been amended, restated, or otherwise modified (the "Security Agreement"), Debtor granted to Agent a continuing security interest in all of Debtor's right, title, and interest in and to certain intellectual property assets, including, without limitation, the patents and patent applications set forth on Schedule A attached hereto (the "Patent Collateral") and the trademark registrations and applications set forth on Schedule B attached hereto (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 29, 2016, at Reel/Frame 038117/0488, and on March 13, 2018, at Reel/Frame 045194/0570, with respect to the Patent Collateral, and on March 29, 2016, at Reel/Frame 5759/0451, with respect to the Trademark Collateral; and

WHEREAS, any and all secured obligations as defined by the Security Agreement have been satisfied, and the requirements of the Security Agreement for discharge of the liens in the Patent Collateral and the Trademark Collateral have been satisfied.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Patent Collateral and the Trademark Collateral thereunder.
