INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the "Agreement") is dated as of May 19, 2017, by and between Golden State Bulb Growers, Inc, with an address at 3060 Hilltop Road, Moss Landing, CA 95039, USA ("Assignor") and DNA Green Group B.V., with an address at Coldenhovenlaan 6, 2676 ZG, De Lier, the Netherlands (the "Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of all right, title and interest in and to certain intangible property and related proprietary rights, interests and protections, throughout the world, including, without limitation, any and all plant breeder's rights, plant variety rights, patents and patent applications, all other proprietary information and other intellectual property in and to which the Seller has, or purports to have, any right, title or interest, including as listed in Annex A other than intellectual property related to the seed grown tuberous Begonia product line; and all registrations and applications for registration and common law rights of each of the foregoing worldwide, and all issuances, extensions and renewals of such registrations and applications (collectively, the "Owned Intellectual Property Rights");

WHEREAS, Assignor desires to assign to Assignee all of its right, title and interest in and to the Intellectual Property of Assignor.

WHEREAS, Assignee desires to accept such assignment of the Intellectual Property of Assignor.


NOW, THEREFORE, in consideration for the mutual promises contained in this Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment of Owned Intellectual Property Rights. Assignor hereby assigns, grants, transfers, conveys and relinquishes exclusively to Assignee, its successors, assigns and legal representatives, all of Assignor's right, title and interest in and to the Owned Intellectual Property Rights of Assignor, including, without, limitation: (i) the trademarks, together with the good will symbolized by the trademarks as listed in Annex A, and including any and all claims for past infringement thereof and (ii) the patents as listed in Annex A and the improvements and inventions disclosed in said patents throughout the world, including all claims and causes of action for damages for past

infringement, and all divisions, reexaminations, reissues, substitutions, continuations, continuations-in-part and extensions thereof. Such assignment, transfer and conveyance by Assignor includes the right of Assignee to file applications for such Owned Intellectual Property Rights and to obtain patents, utility models, industrial models and designs for said inventions and improvements in Assignee's own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said inventions and all rights to register said inventions and Owned Intellectual Property Rights in appropriate registries. Assignor agrees that it will communicate to said Assignee or its representatives any facts known to Assignor respecting said Owned Intellectual Property Rights and improvements and inventions disclosed in said patents, and testify in any legal proceedings, sign all lawful papers, execute all applications, make all rightful oaths and generally do everything possible to aid said Assignee, its successors, assigns and nominees, to perfect such right, title and interest in said Owned Intellectual Property Rights in Assignee and to obtain and enforce proper protection for said Owned Intellectual Property Rights in all countries, and asserts that it will not execute any agreements inconsistent therewith.
