TRADEMARK ASSIGNMENT



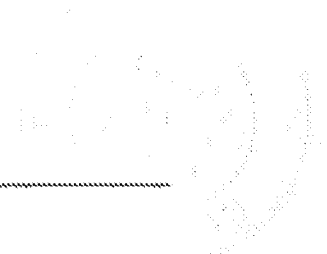
