## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, EBY-BROWN COMPANY, LLC, a Delaware limited liability company (“Debtor”), granted a security interest in and lien upon certain trademarks and related rights to Wells Fargo Capital Finance, LLC, as successor by merger to Wachovia Capital Finance Corporation (New England) (“Secured Party”) as set forth in the Trademark Collateral Assignment and Security Agreement, dated as of April 16, 2010, between Debtor and Secured Party (the “Trademark Security Agreement”);

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
