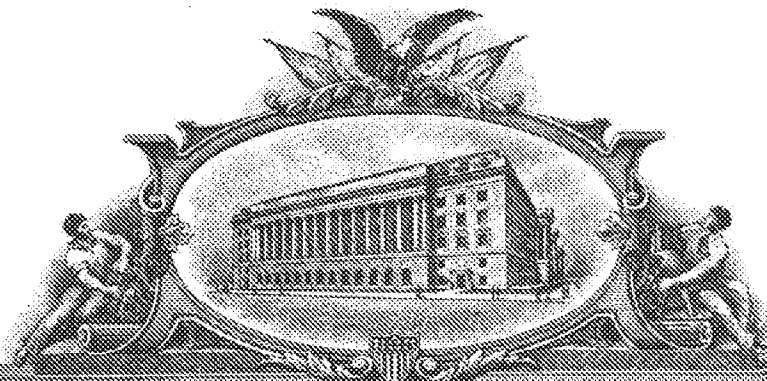



TERMINATION OF ASSIGNMENT AGREEMENT

THIS TERMINATION OF ASSIGNMENT AGREEMENT (the "Termination of Assignment"), dated as of May 24, 1997, is entered into between Internationale Nederlanden (U.S.) Capital Corporation, a Delaware corporation ("ING Capital"), and ING Merger, Inc., a Delaware corporation f/k/a TSO, Inc. ("ING Merger"), as follows:

Recitals

WHEREAS, ING Merger and ING Capital are parties to that Amended and Restated Credit Agreement, dated as of October 6, 1995, between TSO, Inc. and TSO Retail Holdings, Inc., as Borrowers, and ING Capital, as Lender (the "Credit Agreement");

WHEREAS, pursuant to the Credit Agreement, TSO, Inc. and TSO Retail Holdings, Inc. entered into the Assignment for Security of Copyrights, Patents and Trademarks, dated as of October 6, 1995, in favor of ING Capital (the "Assignment") granting ING Capital a security interest in the Intellectual Property Collateral (as defined in the Assignment) of TSO, Inc and TSO Retail Holdings, Inc.;

WHEREAS, TSO Retail Holdings, Inc. merged with and into TSO, Inc., and TSO, Inc. as the surviving corporation changed its name to ING Merger, Inc.;


WHEREAS, ING Capital and ING Merger mutually desire to terminate the Assignment and all rights of ING Capital relating to any of the assets constituting Intellectual Property Collateral of ING Merger;

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree to terminate the Assignment, and ING Capital agrees to release its security interests in any of the Intellectual Property Collateral of ING Merger arising out of the Credit Agreement and the Assignment; PROVIDED, HOWEVER, that this Termination of Assignment shall not become effective until the closing of the Asset Purchase Agreement, dated as of May 20, 1997, by and among Consolidated Vision Group, Inc., a Delaware corporation, TSO, Inc. and TSO Retail Holdings, Inc.

IN WITNESS WHEREOF, the parties have executed this Termination of Assignment as of the date first written above.
