I, Mary Tortorice, being hereby warned that willful false statement and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of this registration, declare that:

1. I am the General Counsel and Chief Compliance Officer of Sazerac Company, Inc. and I am authorized to execute this declaration.
2. The assignment of U.S. Application Serial No. 72050646 for the mark OLE (stylized), U.S. Registration No. 679,747, (the "OLE Registration") from Sazerac Company, Inc. to Sazerac Brands, LLC in the attached Confirmatory Trademark Assignment Agreement was made in error.
3. On September 16, 1993, Sazerac Company, Inc. assigned the OLE Registration to Kanematsu Corporation, recorded at Reel/Frame 1025/0236.
4. On April 1, 2005, Kanematsu Corporation assigned the OLE Registration to Nippon Liquor Ltd., recorded at Reel/Frame 3313/0462.
5. Due to a clerical error, the OLE Registration was inadvertently included in the attached Confirmatory Trademark Assignment Agreement between Sazerac Company, Inc. to Sazerac Brands, LLC (recorded at Reel/Frame 5666/0336) when in fact Sazerac Company, Inc. was not the owner of this registration.
6. To address this clerical error and inconsistency in the chain of title for the OLE Registration, I have revised the Confirmatory Trademark Assignment Agreement by crossing out the OLE Registration.

7. Nippon Liquor Ltd. should be listed as the owner of record of the OLE

Registration.
