**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of April 30, 2019, is made by Credit Suisse AG, as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of Turnitin, LLC, a California limited liability company (the "Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below). For the purposes of this Termination, "Trademarks" shall have the meaning assigned to such term in the Security Agreement (as defined below) and shall include, without limitation, those registrations and applications set forth on Schedule A hereto.

**WHEREAS**, pursuant to (i) that certain Second Lien Security Agreement, dated as of July 31, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by, among others, the Grantor and the Collateral Agent, (ii) that certain Trademark Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "iParadigms Trademark Security Agreement"), dated as of July 31, 2014, made by the Grantor in favor of the Collateral Agent, and (iii) that certain Trademark Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "VeriCite Trademark Security Agreement" and, together with the Security Agreement and the iParadigms Trademark Security Agreement, the "Security Agreements"), dated as of May 2, 2018, made by the Grantor in favor of the Collateral Agent, the Grantor granted to the Collateral Agent a security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademarks;

**WHEREAS**, the security interest in the Trademarks granted by the Grantor to the Collateral Agent under (i) the iParadigms Trademark Security Agreement was recorded at the United States Patent and Trademark Office on August 4, 2014 at Reel 5336 and Frame 0378 and (ii) the VeriCite Trademark Security Agreement was recorded at the United States Patent and Trademark Office on May 9, 2018 at Reel 6362 and Frame 0081; and

**WHEREAS**, the Collateral Agent has agreed to irrevocably terminate, release and discharge its security interest and lien on all of the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantor secured by the Trademarks pursuant to the Security Agreements, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent, without representation, recourse or warranty of any kind, hereby irrevocably terminates, releases and discharges all of its mortgages, liens, and security interests in all of the Grantor's right, title and interest in, to and under the Trademarks and hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Trademarks to the Grantor.


2. The Collateral Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.


3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF (OTHER THAN SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW).
