RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of April 30, 2019, by ARES CAPITAL CORPORATION, a Maryland corporation (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Coolray Heating and Cooling, LLC, a Delaware limited liability company (“Coolray”), Environmental Conditioning, LLC, a Delaware limited liability company (“EC”), New Abacus, LLC, a Delaware limited liability company (“New Abacus”) and Berkeys LLC dba Berkeys Air Conditioning Plumbing and Electrical, formerly B. S. & S. Services, Inc., a Delaware limited liability company (“Berkeys” and, together with Coolray, EC and New Abacus, the “Grantors” and each a “Grantor”) and Secured Party were parties to that certain Trademark Security Agreement dated as of March 2, 2016 (the “Security Agreement”) pursuant to which the Grantors granted a security interest to Secured Party in certain Trademarks as security for certain obligations owing by Grantors to Secured Party;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 2, 2016, at Reel 5744, Frame 0221;

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Grantors granted to the Secured Party, a security interest (the “Security Interest”) in, to and under the Trademark Collateral, including the trademarks set forth on Schedule I (the “Released Collateral”);

WHEREAS, Grantors have satisfied and fulfilled all of their obligations to release the Secured Party’s security interest in the Trademarks; and

WHEREAS, Grantors have requested that Secured Party release the security interest in the Released Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases and forever discharges the Trademark Security Agreement and the Security Interest in the Released Collateral, and retransfers and reassigns to the Grantors any right, title or interest the Secured Party may have in, to or under the Grantors’ Released Collateral.
