RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE **OF SECURITY INTEREST IN TRADEMARKS** is made as of April 30, 2019, by ARES CAPITAL CORPORATION, a Maryland corporation (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Plumline Services, LLC, a Colorado limited liability company (the “Grantor”) and Secured Party were parties to that certain Trademark Security Agreement dated as of May 2, 2018 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks as security for certain obligations owing by Grantor to Secured Party;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 4, 2018, at Reel 6367, Frame 0576;

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Grantor granted to the Secured Party, a security interest (the “Security Interest”) in, to and under the Trademark Collateral, including the trademark set forth on Schedule 1 (the “Released Collateral”);

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Secured Party’s security interest in the Trademarks; and

WHEREAS, Grantor has requested that Secured Party release the security interest in the Released Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases and forever discharges the Trademark Security Agreement and the Security Interest in the Released Collateral, and retransfers and reassigns to the Grantor any right, title or interest the Secured Party may have in, to or under the Grantor’s Released Collateral.
