ASSIGNMENT OF TRADEMARK

This Assignment of Trademark (the “Assignment Agreement”), dated April 25, 2019, is made and entered into by and between Hip Chick Farms, Inc., a California corporation (“Assignor”) and Advantage Capital Agribusiness Partners, L.P., a Delaware limited partnership, (“Assignee”):

WHEREAS, on April 8, 2019, by public sale conducted under Section 9610 of the California Uniform Commercial Code, for good and valuable consideration, Assignee acquired all of Assignor’s rights, interests and claims in, and title to the trademark set forth in the table attached hereto as **EXHIBIT A** together with the common law rights and goodwill associated therewith (the “Trademark”);

WHEREAS, Assignor wishes to confirm by virtue of this Assignment Agreement that all worldwide rights, interests, and claims in, and title to the Trademark, together with the common law rights and goodwill associated therewith, have been assigned to Assignee.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Assignor, effective as of April 8, 2019, hereby contributes, conveys, grants, sets over, assigns, and transfers to Assignee and its successors and assigns, and Assignee hereby accepts, Assignor’s entire worldwide right, interest and claim in, and title to the Trademark, together with the common law rights and goodwill associated therewith, as listed in the attached **EXHIBIT A**, together with the right to sue for and collect upon all claims for profits and damages as a result of past infringement of the Trademark, if any, in each case whether now existing or hereafter created, together with the proceeds thereof.

Assignor hereby constitutes and appoints Assignee as Assignor’s true and lawful attorney in fact, with full power of substitution in Assignor’s name and stead, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest or perfect the aforesaid rights and related causes of action more effectively in Assignee or to protect the same or to enforce any claim or right of any kind with respect thereto.

Each party represents that it has the power and authority to enter into this Assignment Agreement. If any term of this Assignment Agreement is held void, voidable, invalid, inoperative or unenforceable for any reason, the remainder of such term shall be amended to achieve as closely as possible the effect of the original term, and all other terms shall continue in full force and effect.

The terms and covenants of this Assignment Agreement shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor and its assigns. This Assignment Agreement may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall constitute but one and the same agreement.
