**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK COLLATERAL**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Termination and Release”), is entered into as of April 30, 2019 by **BANK OF AMERICA, N.A.**, as collateral agent for the Secured Parties (as defined in the Trademark Security Agreement referred to below) (in such capacity, the “Agent”) in connection with the grant of security interests in certain trademarks by the Grantor party to the Trademark Security Agreement referred to below ( the “Assignor”), in favor of the Agent. Capitalized terms used and not otherwise defined herein have the meanings assigned to them in (i) the ABL Security Agreement, dated as of July 1, 2014 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time), among Winebow Holdings, Inc. (“Winebow”), The Vintner Group, Inc. (“Vintner”), the Co-Borrowers party thereto, The Winebow Group, LLC (“Holdings”), Boston Wine Company, Ltd., the Subsidiary Guarantors party thereto from time to time and the Agent or (ii) the ABL Credit Agreement, dated as of July 1, 2014 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time), among Winebow, Vintner, the Co-Borrowers party thereto from time to time, Holdings, the lenders party thereto from time to time and the Agent, as applicable.

**WITNESSETH:**

WHEREAS, the Assignor entered into an agreement with the Agent which was recorded in the Trademark Division of the United States Patent and Trademark Office on July 1, 2014 (the “Trademark Security Agreement”) for the purpose of providing certain Trademarks as collateral security for the payment and performance of certain obligations of the Assignor to the Agent; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Liens on and security interests in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term “Trademark Collateral”, as used herein, means the Trademark listed on Schedule A hereto.

2. Release of Security Interest. The Agent hereby (i) terminates, cancels, releases and discharges all of its Liens on and security interests in the Trademark Collateral without representation, warranty or recourse of any kind or nature, and (ii) reassigns any right, title and interest it may have in, to and under the Trademark Collateral to the Assignor.

3. Further Assurances. The Agent shall, at the Assignor’s sole cost and expense, and without representation, warranty or recourse, take all further actions, and provide to the Assignor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or

other instruments) reasonably requested by the Assignor to more fully and effectively effectuate the purposes of this Termination and Release.

4. Governing Law. THIS TERMINATION AND RELEASE, AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
