## **TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 1, 2019, by **ANTARES CAPITAL LP**, as Administrative Agent ("**Agent**").

### **WITNESSETH:**

WHEREAS, Agent and Securities Training Corporation a New York corporation ("**Grantor**"), were parties to that certain Intellectual Property Security Agreement, dated as of July 12, 2016 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

b. all renewals and extensions of the foregoing;

c. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


