## RELEASE OF SECURITY INTEREST IN TRADEMARKS

May 1, 2019


**WHEREAS**, the Administrative Agent filed the Notice of Grant of Security Interest in Trademarks with the United States Patent and Trademark Office (the “PTO”) on May 19, 2016 at Reel 5795, Frame 0849;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates and releases, without recourse, representation or warranty, its security interest in and continuing lien upon the Trademarks, effective as of the date first set forth above.

Delivery of an executed signature page of this release by electronic transmission shall be as effective as delivery of a manually executed counterpart hereof. The Administrative Agent acknowledges that this release may be filed with the PTO to evidence the termination and release granted herein.
