AGREEMENT TRANSFERRING ASSETS




In consideration of the mutual promises stated below, Sounddogs.com, Inc. ("Sounddogs"), Lon Bender and Wylie Stateman agree as follows:

1. Sounddogs hereby transfers and assigns to Lon Bender and Wylie Stateman all its right, title and ownership of the Soundelux Trademark together with all associated good will, the Soundelux Logo together with all associated good will, and the www.Soundelux.com URL. Sounddogs believes that it has clear title to these assets and has the right to assign them to Bender and Stateman. Sounddogs has not assigned title in the assets to anyone else.
2. Lon Bender and Wylie Stateman grant Sounddogs with an irrevocable, perpetual license to use the Soundelux Trademark and Logo for the sole purposes of the marketing, sales, and distribution of the Soundelux Sound Effects Library. This license may be transferred to any person acquiring the Soundelux Sound Effects Library.
3. In the event that Sounddogs is sold and the sale includes the Soundelux Sound Effects Library, Lon Bender and Wylie Stateman agree to the following: a) they shall provide a soundelux.com home page link to the third party's Soundelux Sound Effects Library webpage; b) they shall use commercially reasonable efforts to promote the Soundelux Sound Effects Library; c) they shall provide a marketing quote about the Soundelux Sound Effects Library for use in its marketing.

The parties shall cooperate on the filing of such documentation as may be necessary to perfect the transfer and assignment of the trademark and logo and URL specified above.

This Agreement contains the entire understanding of the parties regarding its subject matter and replaces all prior negotiations and discussions. In the event of legal action to interpret or enforce it, the prevailing party shall recover reasonable attorneys' fees and costs.

This Agreement is entered into in Los Angeles, California effective December 12, 2018.
