1. Article I of the Corporation's Certificate of Incorporation is hereby deleted and replaced in its entirety as follows:

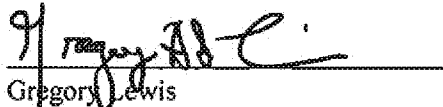
"FIRST: The name of the corporations is True Colors United, Inc. (the "Corporation")."
