NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of April 29, 2019 is made by THE NORTHWESTERN MUTUAL LIFE INSURANCE COMPANY, as administrative agent (in such capacity, together with its successors and assigns, the “Administrative Agent”), in favor of COUNTRY FRESH, LLC, a Delaware limited liability company (the “Company”).

W I T N E S S E T H:

WHEREAS, in connection with the Second Lien Guaranty and Security Agreement, dated as of July 19, 2017, by and among Country Fresh Acquisition Corp., a Delaware corporation, Country Fresh Holdings, LLC, a Delaware limited liability company, the Administrative Agent, the Company and the other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Guaranty and Security Agreement”), the Company executed and delivered the Trademark Security Agreement, dated as of July 19, 2017, in favor of the Administrative Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Company pledged and granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and lien on all of the Company’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks and Trademark Licenses set forth on Schedule A attached hereto, together with all goodwill associated with such Trademarks (the “Released Trademark Collateral”);

WHEREAS, the Administrative Agent recorded its security interest in the Released Trademark Collateral with the United States Patent and Trademark Office on July 19, 2017, at Reel/Frame No. 6109/0052; and

WHEREAS, the Administrative Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Second Lien Guaranty and Security Agreement or Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Administrative Agent does hereby release, relinquish and discharge its security interest in and lien on, all of the Company’s right, title and interest in, to and under the Released Trademark Collateral.

SECTION 3. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 4. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
