## AMENDED AND RESTATED TRADEMARK ASSIGNMENT AGREEMENT

This AMENDED AND RESTATED TRADEMARK ASSIGNMENT AGREEMENT (this “Agreement”), dated as of May 3, 2019, is made by Univision Communications Inc., a Delaware corporation (“Assignor”), in favor of Gizmodo Media Group, LLC, a Delaware limited liability company (“Assignee”). The parties to this Agreement are sometimes referred to herein, individually, as a “Party” and, collectively, as the “Parties.”

WHEREAS, the Parties entered into that certain Trademark Assignment Agreement, dated as of April 4, 2019 (the “Original Agreement”);

WHEREAS, this Agreement amends, restates and replaces the Original Agreement in its entirety; and

WHEREAS, in connection with the closing of the transaction under that certain Securities Purchase Agreement (the “Purchase Agreement”), dated as of April 8, 2019, by and among, for purposes of Section 7.1 of thereof only, Assignor, Univision Interactive Media, Inc., a Delaware corporation, Onion Holdco, LLC, a Delaware limited liability company, and G/O Media, Inc., a Delaware corporation, Assignor desires to assign, and Assignee desires to accept, the Assigned Trademarks (as defined below) in accordance with this Agreement.

NOW, THEREFORE, in consideration of the mutual representations, warranties, promises, covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement.

2. Assignment. Assignor hereby irrevocably transfers, assigns and conveys to Assignee, and Assignee hereby accepts, absolutely and forever, throughout the universe, all of Assignor’s right, title and interest, whether statutory or at common law, in and to the trademarks listed on Schedule 1 attached hereto (the “Assigned Marks”), including, but not limited to, all goodwill associated with, and symbolized by, the Assigned Marks, together with all corresponding registrations and applications to register the Assigned Marks, including the registrations listed on Schedule 1, as well as all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain proceeds relating to those infringements.

3. Further Actions. Following the date hereof, Assignor shall take such action as may be reasonably necessary to effectuate the assignment and transfer of the Assigned Marks to Assignee.

4. Power of Attorney. Assignor hereby irrevocably grants Assignee power of attorney to execute and deliver any of the documents necessary for the transfer of the Assigned Trademarks on Assignor’s behalf in its name and to do all other lawfully permitted acts to transfer the Assigned Trademarks to Assignee and further the transfer, issuance, prosecution and maintenance of all intellectual property rights therein, to the full extent permitted by Law. The power of attorney is coupled with an interest and shall not be impacted by Assignor’s subsequent incapacity.

5. Miscellaneous. Sections 7.2 (No Third-Party Beneficiaries), 7.3 (Entire Agreement), 7.4 (Successors and Assigns), 7.5 (Counterparts), 7.6 (Titles), 7.7 (Notices), 7.8 (Governing Law), 7.9 (Consent to Jurisdiction), 7.10 (Waiver of Trial by Jury), 7.11 (Amendment or Modification), 7.12 (Waivers), 7.13

(Specific Performance), 7.14 (Cumulative Remedies), 7.16 (Expenses), 7.17 (Construction) and 7.18 (Severability of Provisions) of the Purchase Agreement are incorporated by reference herein, *mutatis mutandis*.




