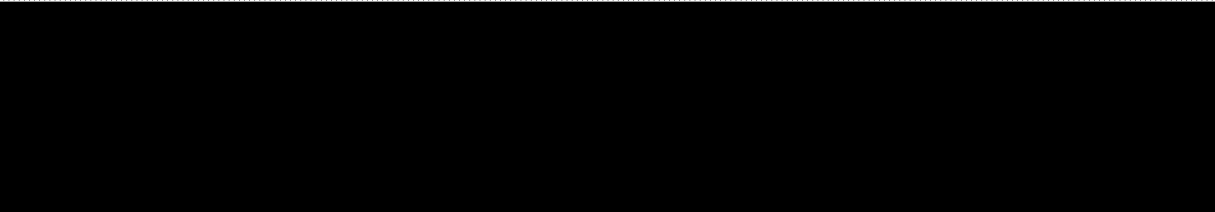

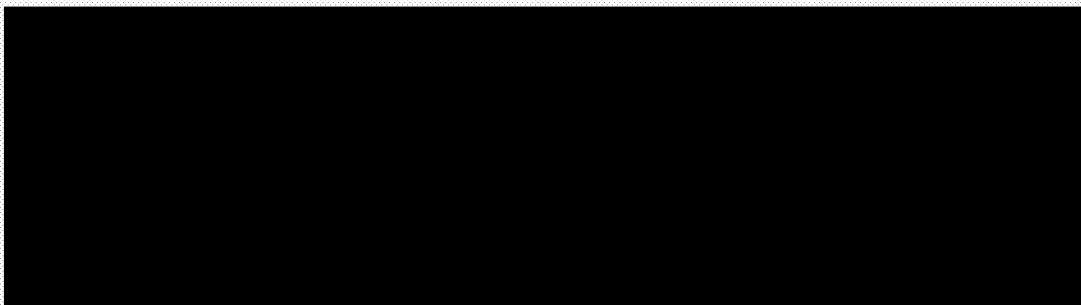

WHEREAS USTA desires to purchase and obtain an assignment of all rights, title and interests in the NJTL OF TRENTON Works and the Trademarks for the sport of Tennis, only;

NOW THEREFORE, the parties agree as follows:

1. GRANTS.

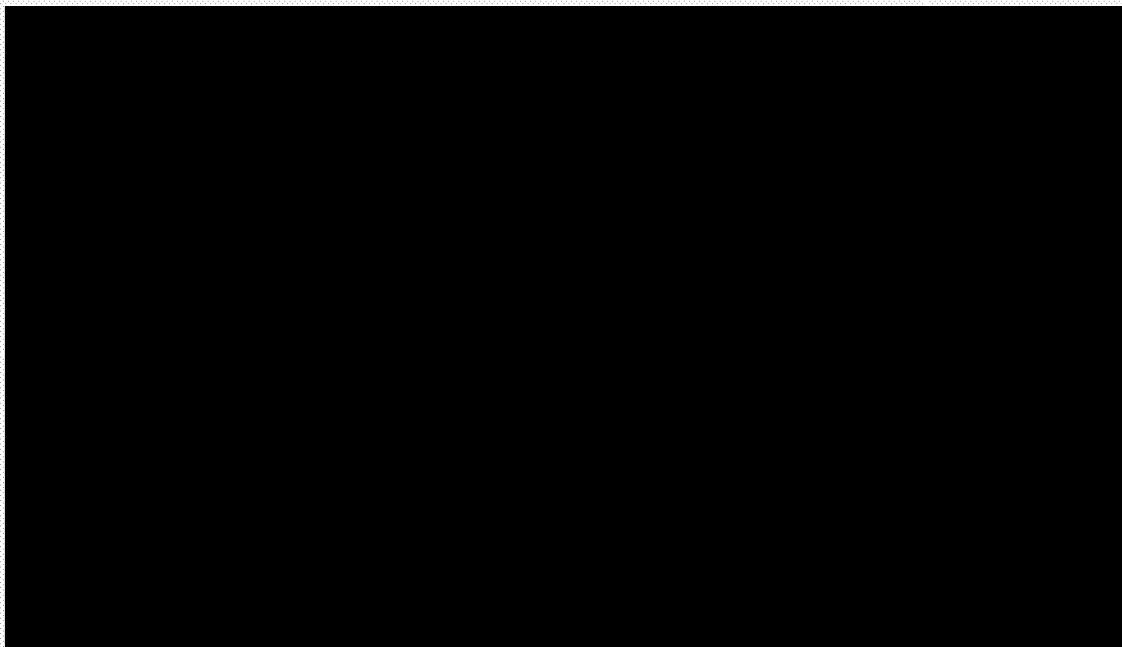

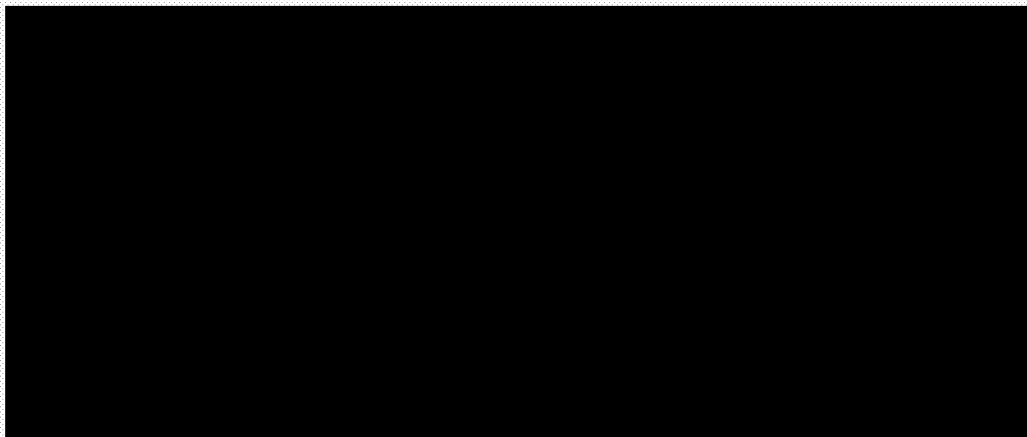
