RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of April 22, 2019 (this "Release"), is made by BANK OF AMERICA, N.A., whose address is 901 Main Street, 14th Floor, TX1-492-14-04, Dallas, TX 75202, acting in its capacity as the Collateral Agent (in such capacity, the "Agent") under that certain Trademark Security Agreement dated as of November 26, 2013 (as amended, supplemented or modified from time to time, the "Security Agreement") between PCI GAMING AUTHORITY, an unincorporated, chartered instrumentality of the Poarch Band of Creek Indians, a federally recognized Indian tribe ("Grantor"), whose address is 303 Poarch Road, Atmore, AL 36502, and Agent.

Pursuant to the Security Agreement, Grantor granted to Agent, for the benefit of the Secured Parties referenced therein, a security interest in and lien upon all of Grantor's Trademark Collateral (as defined in the Security Agreement), including, without limitation, those specific trademark registrations and applications listed on Exhibit A attached hereto (the "Released Trademarks"), and the goodwill associated therewith.

The Security Agreement was recorded on December 16, 2013, at Reel/Frame 5174/0237 in the United States Patent and Trademark Office.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in and to the Trademark Collateral, including the Released Trademarks, and the goodwill associated therewith, without representation or warranty of any kind, express or implied.
