INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of April 1, 2019, is between XCELDYNE, LLC., a North Carolina limited liability company ("Assignor"), and CYCRA, INC., a North Carolina corporation ("Assignee"). Assignor and Assignee are referred to herein individually as a "Party" and collectively, as the "Parties". Capitalized terms used in this Assignment and not otherwise defined have the meanings set forth in the Agreement.

RECITALS:

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement (the "Agreement") whereby Assignor has agreed to sell the Purchased Assets to Assignee and Assignee has agreed to acquire same from Assignor;

WHEREAS, pursuant to the foregoing, as part of the Intellectual Property included among the Purchased Assets, Assignor desires to convey, transfer, assign and deliver to Assignee, and Assignee desires to accept from Assignor, the Cycra Marks and Cycra Patents set forth on Exhibits A and B, respectively, to this Assignment; and

WHEREAS, Assignee desires Assignor to enter into this Assignment so that Assignee may record with the United States Patent and Trademark Office, and other applicable governmental authorities and other registrars, the transfer the record ownership of the Cycra Marks and the referenced Cycra Patents to Assignee.

NOW, THEREFORE, for valuable consideration, including the consideration received by Assignor under the Agreement, the receipt of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Cycra Marks. Assignor hereby sells, assigns, conveys, grants and transfers to Assignee, and its successors and assigns, all of Assignor's right, title and interest, of whatever kind, throughout the world, in and to the Cycra Marks set forth on Exhibit A, together with all of the goodwill associated with and symbolized by such Cycra Marks, and all other corresponding rights at common law or otherwise with respect thereto that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect.

2. Cycra Patents. Assignor hereby sells, assigns, conveys, grants and transfers to Assignee, and its successors and assigns, all of Assignor's right, title and interest in and to the Cycra Patents set forth on Exhibit B, including the right to file, if permissible, foreign patent applications corresponding to such Cycra Patents, and the right to claim the priority date of said Cycra Patents and any legal equivalents thereof, and any and all corresponding patents and patent applications in the United States of America and all foreign countries which have been or may be granted therefor and thereon, and to any and all divisions, continuations, continuations-in-part, reexaminations, substitutions, reissues, extensions and renewals of such Cycra Patents.


3. Conflict With Agreement. This Assignment is subject in all respects to the terms and conditions of the Agreement. This Assignment does not in any way modify or expand any of
