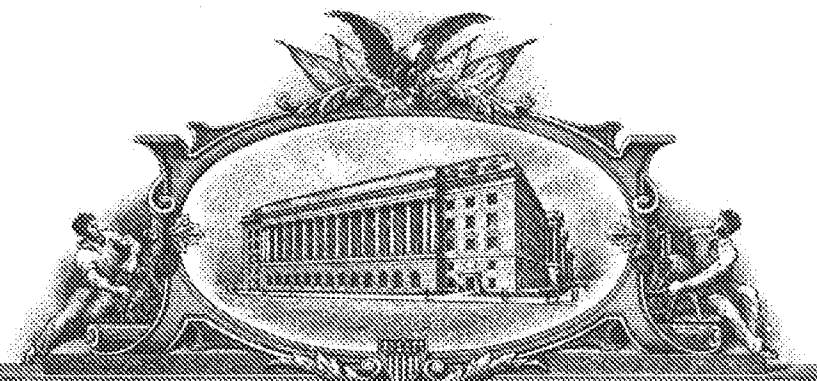

TSO, Inc., a Delaware corporation (the "Company"), does hereby certify that:

**FIRST:** The Corporation is incorporated pursuant to the General Corporation Law of the State of Delaware ("DGCL").

**SECOND:** The Company owns all of the outstanding shares of each class of the capital stock of TSO Retail Holdings, Inc., a Delaware corporation ("Retail Holdings").

**THIRD:** The Company, by the following resolutions of its Board of Directors, duly adopted effective as of the 30th day of April, 1997, determined to merge into itself Retail Holdings (the "Retail Holdings Merger") on the conditions set forth in such resolutions:

**RESOLVED**, that (a) the Company shall merge into itself its wholly owned subsidiary, Retail Holdings, (b) the Company shall be the surviving corporation to be governed by the DGCL, (c) the Retail Holdings Merger shall have the effects provided in the DGCL, (d) the Company shall change its corporate name to ING Merger, Inc., and (e) the title of the Company's by-laws shall be amended to reflect the change of the Company's name.

**FURTHER RESOLVED**, that the President and the Secretary of the Company be, and they hereby are, directed to make, execute and acknowledge a certificate of ownership and merger setting forth a copy of these resolutions and to file the same in the office of the Secretary of State of Delaware and a certified copy thereof in the Office of the Recorder of Deeds of New Castle County, Delaware as required by Section 253 of the DGCL; and

**FURTHER RESOLVED**, that the officers of the Company be, and each of them hereby is, authorized, for and on behalf of the Company, to execute any and all other documents and do any and all other things that such officers or any of them may deem appropriate in order to cause the transactions contemplated by the Retail Holdings Merger to be consummated.
