TRADEMARK TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TRADEMARK TERMINATION AND RELEASE OF SECURITY INTEREST (the "Trademark Termination and Release"), dated as of May 2, 2019, is made by ASSOCIATED BANK, NATIONAL ASSOCIATION, a national banking association (the "Secured Party"), in favor of OPEN ACCESS TECHNOLOGY INTERNATIONAL, INC., a Minnesota corporation (the "Debtor").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, dated as of October 31, 2018, made by the Debtor in favor of the Secured Party (the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by the Debtor to the Secured Party in certain Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 5, 2018 at Reel 006475/Frame 0396; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Trademark Termination and Release, the Secured Party hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall have the meaning provided by reference in the Trademark Security Agreement and shall include all of the Debtor's right, title and interest of every kind and nature as of the date hereof in the Debtor's trademarks, trademark applications, and trademark registrations (including, without limitation, those items listed on Schedule 1 attached hereto).

2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Secured Party in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. At the cost and expense of the Debtor, the Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

4. Counterparts. This Trademark Termination and Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

5. Governing Law. This Trademark Termination and Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of Minnesota.

IN WITNESS WHEREOF, the Secured Party has caused this Trademark Termination and Release to be executed and delivered by its duly authorized officer as of the date first set forth above.

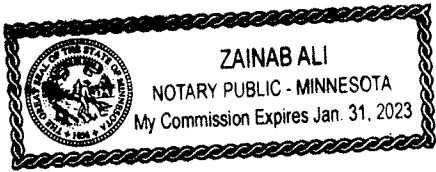




