## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "IP Assignment"), dated as of March 29, 2019, is made by Abrams & Company Publishers, Inc., a Delaware Corporation ("Seller"), having an address of 16310 Bratton Lane, Suite 250, Austin, TX 78728-2403, in favor of Frog Street Press, LLC, a Delaware limited liability company ("Purchaser"), having an address care of Excelligence Learning Corporation, 20 Ryan Ranch Road, Suite 200, Monterey CA, 93940.

**WHEREAS**, Seller and Purchaser have entered into a certain Asset Purchase Agreement, dated as of even date herewith (the "Purchase Agreement"), pursuant to which, among other things, Seller has agreed to sell, assign and transfer to Purchaser, and Purchaser has agreed to purchase and acquire from Seller certain Assets, as more particularly defined and described in the Purchase Agreement;

**WHEREAS**, pursuant to the Purchase Agreement, Seller has agreed to sell, assign and transfer to Purchaser, as part of the Assets, the Assigned Seller Intellectual Property, which includes, but is not limited to, those listed on Schedule I attached hereto, and has agreed to execute and deliver this IP Assignment to evidence the transfer and assignment of the Assigned Seller Intellectual Property, and for recording with governmental authorities, including, but not limited to, the United States Patent and Trademark Office, the United States Copyright Office, and corresponding entities or agencies in any applicable jurisdictions; and

**WHEREAS**, all capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Purchase Agreement.

**NOW THEREFORE**, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Subject to, and as more particularly described in, the Purchase Agreement, the Seller hereby irrevocably assigns and transfers to Purchaser, and Purchaser hereby accepts from Seller, all of such Seller's right, title and interest and goodwill in and to the following (the "Assigned IP"):

(a) all registered or unregistered trade names, trademarks, service marks, logos, symbols, brand names, trade dress, trademark and service mark applications, and trademark and service mark registrations exclusively related to the Titles or the Records and Files, including those listed on Schedule I attached hereto;

(b) all works of authorship, expressions, designs and design registrations, databases and rights to derivative works, whether or not copyrightable, exclusively related to the Titles or the Records and Files, including copyrights, author, performer, moral and neighboring rights, and all registrations, application for registration and renewals of such copyrights, including those listed on Schedule I attached hereto;

(c) all internet domain names listed in Schedule I; and

(d) all inventions, discoveries, trade secrets, business information and all rights therein related to the Titles or the Records and Files.

2. Recordation and Further Actions. Seller hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office and the Register

of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Purchaser. Following the date hereof, upon Purchaser's reasonable request, Seller shall take such steps and actions, and provide such cooperation and assistance to Purchaser and their respective successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned IP to Purchaser, or any assignee or successor thereto.

3. Terms of the Purchase Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Purchaser with respect to the Assigned IP. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.

5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns. Seller shall not assign this IP Assignment without the prior written consent of Purchaser.

6. Severability. The invalidity or unenforceability of any of the terms, conditions or provisions hereof shall not limit or impair the operation or validity of any other term or provision of this IP Assignment, and the remainder of this IP Assignment shall remain operative and in full force and effect.

7. Governing Law. This IP Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this IP Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Texas, without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction).
