CONTRIBUTION AGREEMENT

THIS CONTRIBUTION AGREEMENT (this "Agreement"), entered into as of December 31, 2016, by and between IAC Publishing, LLC, a Delaware limited liability company ("IAC PUBLISHING") and About, Inc., a Delaware corporation and a wholly-owned subsidiary of IAC Publishing ("ABOUT").

WHEREAS, Inkd, LLC, a Delaware Limited Liability Company ("INKD") and IAC PUBLISHING have entered into a certain distribution and assumption agreement dated December 31, 2016, pursuant to which IAC PUBLISHING received from INKD certain assets and liabilities related to the BellyBallot business including but not limited to those assets and agreements identified in **Exhibit A** (the "BellyBallot Assets and Liabilities"); and

WHEREAS, IAC PUBLISHING desires to contribute to ABOUT the BellyBallot Assets and Liabilities; and

WHEREAS, the Board of Managers of IAC PUBLISHING has determined that it is in the best interests of IAC PUBLISHING to contribute the BellyBallot Assets and Liabilities to the capital of ABOUT.

NOW, THEREFORE, in consideration of the premises and mutual undertakings, the undersigned parties covenant and agree as follows:

- Section 1. <u>Contribution</u>, IAC PUBLISHING hereby conveys, transfers, assigns and delivers to ABOUT, effective as of the Effective Time (as defined below) all of IAC PUBLISHING's right, title and interest in, to and under the BellyBallot Assets and Liabilities (the "Contribution").
- Section 2. <u>Acceptance by ABOUT</u>. ABOUT acknowledges and accepts the Contribution and the receipt of the BellyBallot Assets and Liabilities from IAC PUBLISHING, effective as of the Effective Time, and will record the Contribution on the books and records of the company.
- Section 3. <u>Assignment and Assumption of Business Agreements</u>. IAC PUBLISHING hereby assigns all of its right, title and interest in and to all legal contracts and agreements relating to the BellyBallot business, including those agreements set forth on Exhibit A, and ABOUT hereby accepts such assignment and assumes, and agrees to perform, all of IAC PUBLISHING's obligations under such agreements.
- Section 4. <u>Effective Time</u>. The transactions contemplated hereby shall be effective as of 12:02 a.m Eastern Time, on January 1st, 2017 (the "Effective Time").

Section 5. Miscellaneous.

- (a) Entire Agreement. This Agreement embodies the entire agreement and understanding of the parties hereto in respect of the subject matter contained herein. This Agreement supersedes all prior agreements and understandings between the parties with respect to such subject matter.
- (b) Amendments and Waivers. Neither this Agreement nor any provision hereof shall be modified, changed, discharged or terminated except by an instrument in writing signed by the party against whom any waiver, change, discharge or termination is sought.
- (c) Further Assurances. Each of IAC PUBLISHING and ABOUT agree to execute and deliver such documents and take such further action as may be necessary or appropriate to effectuate the purpose and intent of this Agreement.

- (d) Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware, regardless of the law that might be applied under principles of conflicts of law.
- (e) Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.


