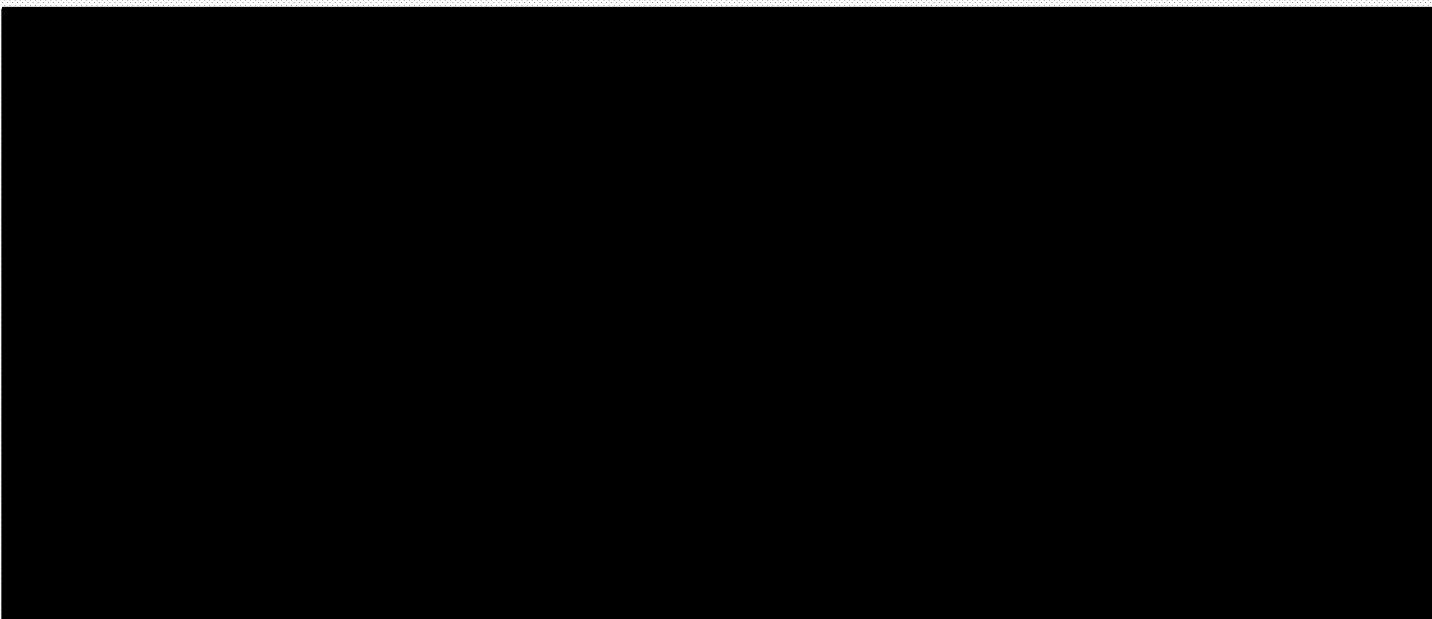
### WITNESSETH:

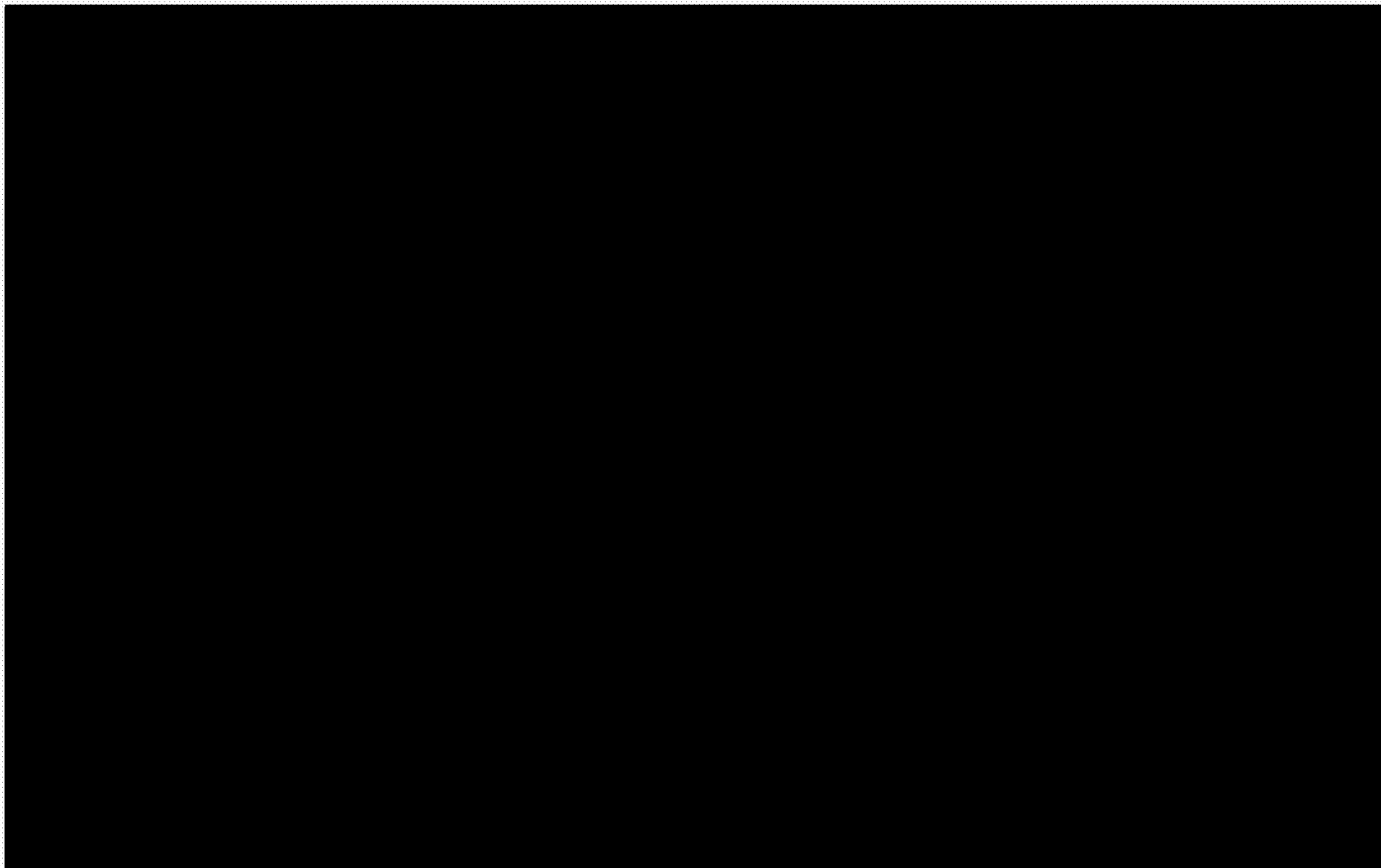
**WHEREAS**, Seller is engaged in the manufacture and sale of baseball bats at its place of business located in Norwalk, CT (the "Business"); and

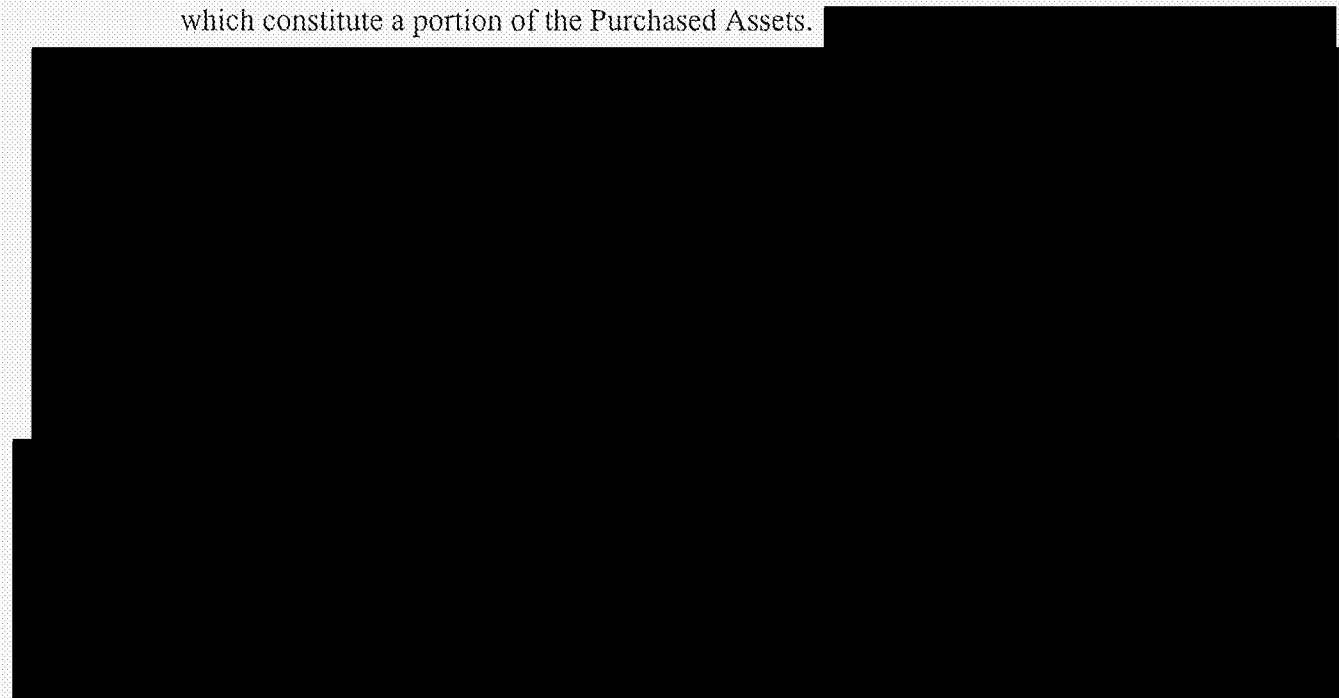

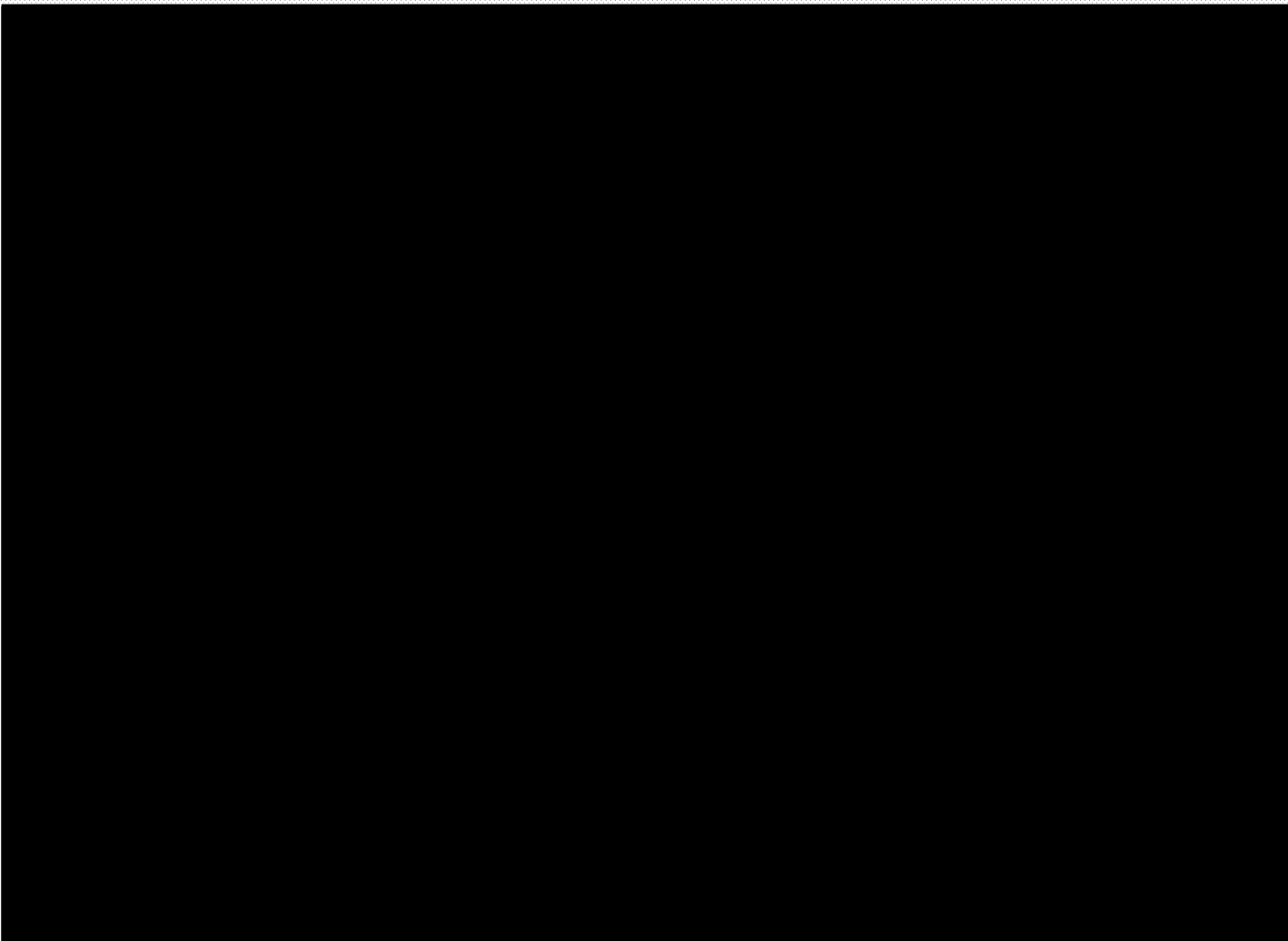


