CONFIRMATORY ASSIGNMENT

WHEREAS, ASSIGNEE and its wholly owned subsidiaries, which operate the contact lens business to which the MARKS pertain, separated from ASSIGNOR pursuant to an Agreement dated April 8, 2019.

NOW, THEREFORE, in consideration of good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR does hereby sell, assign, transfer and convey unto ASSIGNEE its entire right, title and interest in and to the MARKS, and to the applications and/or registrations for the MARKS, together with the goodwill of the business symbolized by the MARKS and the portion of the business of the ASSIGNOR to which the MARKS pertain, including all associated common law rights, and the right to sue and recover for any past infringement thereof.
