RELEASE OF SECOND LIEN SECURITY INTEREST
IN TRADEMARKS

THIS RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of as of May 10, 2019 (the “Effective Date”) from Société Générale, as collateral agent for the benefit of certain lenders (in such capacity, the “Collateral Agent”) to No Fault LLC (the “**Grantor**”).

WHEREAS, the Grantor was party to a Second Lien Security Agreement (as amended, modified or supplemented in accordance with its terms, the "Second Lien Security Agreement") dated as of June 23, 2015 in favor of Collateral Agent and for the benefit of certain lenders;

WHEREAS, pursuant to the Second Lien Security Agreement, the Grantor and the Collateral Agent entered into that certain Intellectual Property Security Agreement, dated as of January 25, 2019 (the “Second Lien Trademark Security Agreement” all capitalized terms used, but not defined, herein have the definition assigned to them in the Second Lien Trademark Security Agreement);

WHEREAS, pursuant to the Second Lien Trademark Security Agreement the Grantor granted to Collateral Agent, for the benefit of the lenders, a security interest in and to all of the Grantor’s right, title and interest in the Grantor’s Intellectual Property Collateral, including the trademarks listed on Exhibit A attached hereto (the "Released Marks"), and the goodwill associated therewith;

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 10, 2018, at Reel 6545, Frame 0480;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of itself, its successors, legal representatives and assigns, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, (i) hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantor, all of Collateral Agent's right, title and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any; and (ii) terminates the Second Lien Trademark Security Agreement with respect to the Released Marks.

This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the law of the State of New York.

IN WITNESS WHEREOF, Collateral Agent has executed this Release of Security Interest in Trademarks as of the Effective Date.
