## TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made effective as of the date signed below ("Effective Date"), by and between Vlad Dragusin, a United States citizen with an address of 499 11<sup>th</sup> Street, Brooklyn, NY 11215 ("Assignor"), and Candylab Toys, Inc., a New York corporation with an address of 179 Christopher Street, New York, NY 10014 ("Assignee"). Assignor and Assignee are sometimes referred to herein individually as a "Party" and collectively as the "Parties."

**WHEREAS**, Assignor is the owner of the trademark CANDYCAR, which is the subject of federal trademark registration Application Serial No. 88/029,415 in the United States Patent and Trademark Office in connection with toy cars ("Mark"), and of all common law rights and goodwill therein;

**WHEREAS**, Assignee is desirous of acquiring all rights in the Mark owned by Assignor, including Application Serial No. 88/029,415, together with the goodwill of the business symbolized thereby;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns, and Assignee hereby accepts, all of the right, title, and interest in, to the Mark, together with the goodwill of the business connected with the use thereof and symbolized thereby, including all associated trademark rights and common law rights, and all issuances, extensions, and renewals thereof, and including:

(a) all rights of any kind whatsoever of Assignor accruing under the Mark provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world (including for the avoidance of doubt, any common law rights);

(b) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to the Mark; and

(c) any and all claims and causes of action with respect to the Mark, whether accruing before, on, and/or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Assignor authorizes the Commissioner for Trademarks and any other governmental officials in the United States and in relevant jurisdictions outside the United States to record and register this Assignment upon request by Assignee.




