TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), effective as of the 3rd day of May, 2019, is made and entered into by and between Luxury Brand Partners, LLC, a Delaware limited liability company with an address at 3800 NE 1st Avenue, 6th Floor, Miami, Florida 33137 ("Assignor") and In Common, LLC, a Delaware limited liability company with an address at 3800 NE 1st Avenue, 6th Floor, Miami, Florida 33137 ("Assignee"). Assignor and Assignee are referred to individually as a "Party" and collectively as the "Parties".

WHEREAS, Assignor is the owner of the trademark IN COMMON in the United States and certain other countries where Licensor has filed trademark applications therefor (together with the United States, the "Territory"), including all registrations, applications, common law, and other rights associated therewith, and all graphic and other versions and modifications thereof, and including the registrations and applications set forth in the attached Exhibit A (collectively, the "Mark");

WHEREAS, Assignee is a subsidiary of Assignor;

WHEREAS, Assignor and Assignee are parties to that certain Trademark License Agreement dated as of November 5, 2018 (the "License Agreement"), pursuant to which Assignor has licensed to Assignee the exclusive right to use the Mark in the Territory;

WHEREAS, in accordance with Section 7 of the License Agreement, Assignor has agreed to assign the Licensed Mark in the Territory to Assignee following such time that an allegation of use has been filed and accepted with the United States Patent and Trademark Office with respect to all then-pending trademark applications in the United States for the Licensed Mark that are based on an intent to use the mark under §1(b) of the Trademark Act, 15 U.S.C. § 1051(b); and

WHEREAS, the conditions described in Section 7 of the License Agreement have been satisfied, and Assignor now desires to transfer its rights in the Mark to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor agrees to assign and hereby sells, assigns, and transfers to Assignee all rights, title, and interests of Assignor in and to the Mark, together with the goodwill of the business associated with the Mark, including without limitation (a) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation damages and payments for past or future infringements and misappropriations of the Mark; and (b) all rights to sue for past, present, and future misappropriation of the Mark.

2. Assignor hereby authorizes and requests the competent authorities to record this Assignment.
3. This Assignment may be executed in any number of counterparts, and by the different Parties in separate counterparts, each of which will be deemed an original for all purposes and all of which together will constitute one and the same instrument.

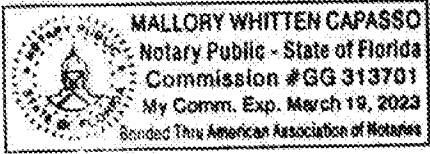

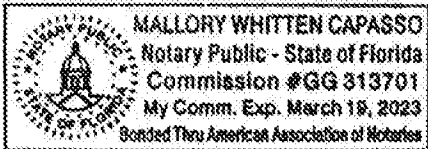
