RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is made as of May 10, 2019 ("Effective Date") executed by JPMorgan Chase Bank, N.A., in its capacity as administrative agent ("Agent") on behalf of the Lenders, in favor of Lund, Inc., a Delaware corporation, Roll-N-Lock Corporation, a Florida corporation, Lund Motion Products, Inc., a Delaware corporation, Bushwacker, Inc., an Oregon corporation, and Belmor, Inc., a Delaware corporation (jointly and severally, the "Grantors" and, each a "Grantor"). Capitalized terms used herein without definition shall have the meanings assigned to them in the Security Agreement (defined below).

WHEREAS, pursuant to the terms and conditions of that certain Credit and Security Agreement dated as of March 28, 2018 (as the same may be amended, modified, extended or restated from time to time, the "Security Agreement"), the Grantors granted to Agent for the benefit of the Lenders a continuing security interest in and to, and Lien upon, all of the Grantors' right, title and interest in the trademarks and trademark applications listed on Schedule I attached hereto (collectively the "Trademarks");

WHEREAS, the Grantors executed and delivered that certain Notice of Grant of Security Interest in U.S. Patents and Trademarks dated as of March 28, 2018 in favor of the Agent (the "Trademark Security Interest") to evidence the Agent's security interest in and Lien on the Trademarks;


WHEREAS, the Trademark Security Interest was recorded with the United States Patent and Trademark Office on March 28, 2018 at Reel 6301 Frame 0521; and

WHEREAS, the Agent wishes to release and restore all of its right, title and interest in and to the Trademarks to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Lenders, hereby terminates, cancels and releases any and all security interests or liens it (or any Lender) has against the Trademarks, and grants, assigns and conveys, without recourse or warranty, to the Grantors any and all rights, title and interest it (or any Lender) may have in or to the Trademarks. The Agent hereby authorizes any Grantor (or its designee) or such Grantor's (or designee's) authorized representative to record this Release with the United States Patent and Trademark Office.
