ARTICLES OF RESTATEMENT
FOR NONPROFIT CORPORATION

Pursuant to §55A-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following for the purpose of restating its Articles of Incorporation.

1. The name of the corporation is: Mission Health System, Inc.
2. The text of the Restated Articles of Incorporation is attached.

 - a. These Restated Articles of Incorporation were adopted by the board of directors and do not contain an amendment.
 - b. These Restated Articles of Incorporation were adopted by the board of directors and contain an amendment not requiring member approval. (Set forth a brief explanation of why member approval was not required for such amendment.)

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
MISSION HEALTH SYSTEM, INC.**

In accordance with the provisions of the North Carolina Nonprofit Corporation Act §55A-10-06, Mission Health System, Inc. (the "Company"), does hereby submit these Amended and Restated Articles of Incorporation for the purpose of superseding, amending and restating the Company's existing articles of incorporation as follows:

1. The name of Company is "ANC Healthcare, Inc."
2. The Company shall be a charitable corporation within the meaning of Section 55A-1-40(4) of the North Carolina General Statutes.
3. The Company is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any corresponding United States Internal Revenue Law (the "Code").
 - (a) Notwithstanding any other provision of these Amended and Restated Articles of Incorporation, the Company shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code or (ii) by a corporation to which contributions are deductible under Section 170(c)(2) of the Code.
 - (b) No part of the net earnings of the Company shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered and to take payments in furtherance of its tax-exempt purposes.
 - (c) No substantial part of the activities of the Company shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Company shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
4. The period of existence of the Company is unlimited.
5. The street address of the registered agent of the Company is 2626 Glenwood Avenue, Suite 550, Raleigh, Wake County, North Carolina 27608 and the registered agent at such address is Corporation Service Company.
6. The principal office address and mailing address of the Company are 425 West New England Avenue, Suite 300, Winter Park, Florida 32789, Orange County.

7. To the fullest extent permitted by the North Carolina Nonprofit Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the Company shall be personally liable for monetary damages for breach of any duty as a director. No amendment or repeal of this article, nor the adoption of any other amendment to these Articles of Incorporation inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.

8. In the event of the termination, dissolution or winding up of the affairs of the Company in any manner or for any reason whatsoever, the directors shall, after paying or making provision for payment of all liabilities of the Company, distribute all of the remaining assets and property of the Company to one or more other organizations exempt under Section 501(c)(3) of the Code as designated by the directors.
