CONFIRMATORY DEED OF MERGER

HYDROCARBON TECHNOLOGY & INNOVATION, LLC, formerly named HEADWATERS HEAVY OIL, LLC, a limited liability company having a principle place of business at 1501 New York Avenue, Lawrenceville New Jersey 08648,

Represented by Eric CAPRANI, acting as CEO

Hereinafter referred to as "HYDROCARBON TECHNOLOGY & INNOVATION"

WHEREAS:

HEADWATERS TECHNOLOGY INNOVATION GROUP, INC., formerly a corporation of the State of Utah, having a principal place of business at 10701 South River Front Parkway, Suite 300, South Jordan, Utah 84095, is the recorded owner of the trademarks listed in Appendix 1 attached hereto (collectively referred hereinafter as the "Subject Trademarks").

On October 27, 2017, the name of HEADWATERS TECHNOLOGY INNOVATION GROUP, INC. was changed to HTI-SERVICES, INC., a corporation of the State of Utah, with a principle place of business at 1501 New York Avenue, Lawrenceville New Jersey 08648, as evidenced by the document attached hereto as Appendix 2, such that HTI-SERVICES, INC. became and is now the successor-in-interest to HEADWATERS TECHNOLOGY INNOVATION GROUP, INC. and therefore became the owner of the Subject Trademarks.

On January 16, 2018, HTI-SERVICES, INC. converted from a Utah corporation to a Delaware limited liability company and changed its name from "HTI-SERVICES, INC." to "HTI-SERVICES, LLC", as evidenced by the document attached hereto as Appendix 3.

On January 1, 2019, HTI-SERVICES, LLC, merged with and into HYDROCARBON TECHNOLOGY & INNOVATION, under the name HYDROCARBON TECHNOLOGY & INNOVATION, LLC ("Merger"), as evidenced by the document attached hereto as Appendix 4.

This Merger resulted in the transfer of the Subject Trademarks owned by HTI SERVICES, LLC to HYDROCARBON TECHNOLOGY & INNOVATION.

IT IS HEREBY CONFIRMED THAT:

HYDROCARBON TECHNOLOGY & INNOVATION hereby declares that the Merger resulted in the transfer of ownership of all rights, title and interests in and to the Subject Trademarks to HYDROCARBON TECHNOLOGY & INNOVATION.

HYDROCARBON TECHNOLOGY & INNOVATION also declares that the transfer of the Subject Trademarks has been consented and accepted under the conditions fixed by agreement between HTI-SERVICES, LLC and HYDROCARBON TECHNOLOGY & INNOVATION, notably in exchange for good and valuable consideration.


Full powers are granted to the bearer of a copy of the present deed to proceed with the recording of the Merger and related change of company name before the relevant Trademark Offices.
