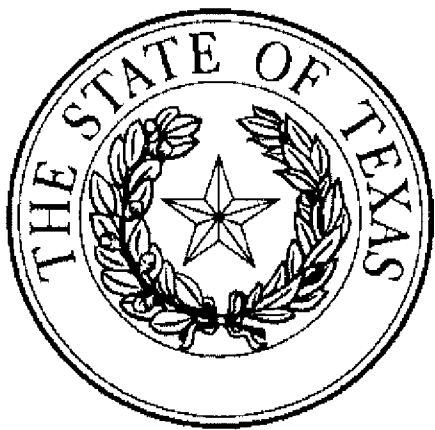


1. The name of the converting corporation is Ennis Paint, Inc., a Texas corporation (the "Corporation").
