**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (this “Termination”), is dated as of May 10, 2019, and made by **PNC BANK, NATIONAL ASSOCIATION** (the “Agent”), to **INMOMENT, INC.**, a Utah corporation (“InMoment”) and **EMPATHICA INC.**, a Delaware corporation (“Empathica”, and together with InMoment, each, a “Grantor,” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of April 2, 2018, made by InMoment in favor of Agent (the “InMoment Security Agreement”), a security interest was granted by InMoment to Agent in certain collateral, including the IP Collateral (as hereinafter defined);

WHEREAS, the InMoment Security Agreement was recorded on April 2, 2018 with the trademark division of the United States Patent and Trademark Office (the “USPTO”) at Reel/Frame 6317/0043 and the patent division of the USPTO at Reel/Frame 045580/0534;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of April 2, 2018, made by Empathica in favor of Agent (the “Empathica Security Agreement”, and together with the InMoment Security Agreement, collectively, the “Security Agreements”), a security interest was granted by Empathica to Agent in certain collateral, including the IP Collateral;

WHEREAS, the Empathica Security Agreement was recorded with the trademark division of the USPTO on April 18, 2018 at Reel/Frame 6317/0065 and the patent division of the USPTO on April 2, 2018 at Reel/Frame 045580/0551;

WHEREAS, Agent now desires to terminate the Security Agreements and terminate, release and discharge its security interest in the IP Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term “IP Collateral,” as used herein, shall collectively have the meaning assigned to such term in each of the Security Agreements.

2. Release of Security Interest. Agent hereby (i) claims no further right, title, or interest whatsoever in, to, or under any and all of the IP Collateral (including the items set forth on Exhibit A hereto), (ii) terminates the Security Agreements and the and terminates, releases and discharges its security interest in the IP Collateral (including the items set forth on Exhibit A hereto), and (iii) reassigns to the applicable Grantor any right, title or interest Agent may have in, to, or under the IP Collateral (including the items set forth on Exhibit A hereto).
