CERTIFICATE OF MERGER

OF

GS ROOFING PRODUCTS COMPANY, INC.

INTO

CERTAINTeed CORPORATION

UNDER SECTION 907 OF THE BUSINESS CORPORATION LAW

1. CertainTeed Corporation, a corporation of the State of Delaware owns all of the outstanding shares of common stock of GS Roofing Products Company, Inc., a corporation of the State of New York.

2. As to each subsidiary corporation, the designation and number of outstanding shares (of each class) and the number of such shares (of each class), if any, owned by the surviving corporation are as follows:

GS Roofing Products Company, Inc.	100 Shares of Common Stock	100

3. The certificate of incorporation of G S Roofing Products Company, Inc. was filed by the Department of State on the 20<sup>th</sup> day of June, 1974 under the original name of Abbeyville Corporation.

4. This Merger has been approved by the Shareholder, CertainTeed Corporation, effective as of December 31, 2014.

5. The surviving corporation is CertainTeed Corporation, a corporation of the state of Delaware, incorporated on the 23rd day of February, 1988, and its application for authority to do business in the State of New York was filed by the Department of State on the 14th day of August, 1996. The merger is permitted by the laws of the state of its incorporation and is in compliance therewith.

6. CertainTeed Corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of any domestic corporation or of any foreign

corporation, previously amenable to suit in the State of New York, and for the enforcement under the Business Corporation Law, of the right of shareholders of any constituent domestic corporation to receive payment for their shares against the surviving corporation; and it designates the Secretary of State of New York as its agent upon whom process against it may be served in the manner set forth in paragraph (b) of Section 306 of the Business Corporation Law, in any action or special proceeding. The post office address to which the Secretary of State shall mail a copy of any process against it served upon him is c/o C T Corporation System, 111 Eighth Avenue, New York, N.Y. 10011.

7. CertainTeed Corporation agrees that, subject to the provisions of Section 623 of the Business Corporation Law, it will promptly pay to the shareholders of each constituent domestic corporation the amount, if any, to which they shall be entitled under the provisions of the Business Corporation Law, relating to the right of shareholders to receive payment for their shares.

8. Each of the constituent domestic corporations hereby certifies that all fees and taxes (including penalties and interest) administered by the Department of Taxation and Finance of the State of New York which are now due and payable by each constituent domestic corporation have been paid and that a cessation franchise tax report (estimated or final) through the anticipated date of the merger, has been filed by each constituent domestic corporation. The said report, if estimated, is subject to amendment. CertainTeed Corporation hereby agrees that it will within 30 days after the filing of the certificate of merger file the cessation franchise tax report, if an estimated report was previously filed, and promptly pay to the Department of Taxation and Finance of the State of New York all fees and taxes (including penalties and interest), if any, due to the Department of Taxation and Finance by each constituent domestic corporation.

9. The merger shall be effective on the 31<sup>st</sup> day of December, 2014.
