RELEASE OF SECURITY INTERESTS IN TRADEMARKS



NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and terminates, releases and discharges any security interest in and lien upon the Trademark Collateral, including the Trademarks listed on Schedule A, and assigns, transfers, and conveys to the Company any and all right, title or interest in, or to, the Trademark Collateral that the Agent may hold.
