TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 15, 2019 ("Release"), is made by BankUnited, N.A. (as successor-in-interest to Herald National Bank) ("Secured Party"), in favor of The ONE Group, LLC, a Delaware limited liability company ("Grantor").

WHEREAS, pursuant to that Amended and Restated Security Agreement dated as of January 24, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Secured Party, and others party thereto and the Grant of Security Interest (Trademarks) dated as of January 24, 2013 ("Trademark Grant") by and among the Grantor and Secured Party, Grantor granted to the Secured Party a security interest in all of the present and future right, title and interest of the Grantor in and to the Collateral (as defined in the Trademark Grant), including the Trademarks; and

WHEREAS, the Trademark Grant was recorded at the United States Patent and Trademark Office ("USPTO") on February 20, 2013 at Reel 4966 Frame 0639.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Grant.

SECTION 2. Termination and Release. Secured Party hereby:

(a) absolutely, unconditionally and irrevocably terminates the Trademark Grant;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the security interest in and to the right, title, and interest in, to, and under the Collateral, including, but not limited to, the Trademarks listed on Schedule 1 attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release with the USPTO at Grantor's expense.



Secured Party, at Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Secured Party will, at Grantor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.


