1. **Parties.** The constituent entities are:

Mississippi Lime Company, a Missouri corporation (Missouri Charter # 00034758).

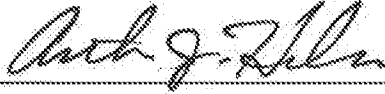
Breen Energy Solutions, LLC, a Pennsylvania limited liability company (Pennsylvania Entity # 3075211).

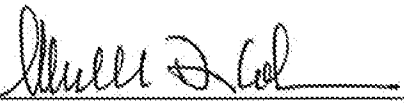
