BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT (this “Agreement”) is made and entered into as of March 1, 2019, by and between PB Texas Behavioral Care, LLC, a Delaware limited liability company (“Buyer”), Assurance Toxicology Services, LLC, a Delaware limited liability company (“Assurance Toxicology”), Elements Screening Services, Inc., a Texas corporation (“Elements Screening”), TRS Behavioral Care, Inc., a Texas corporation (“TRS Behavioral”), Spirit Lodge, LLC, a Texas limited liability company (“Spirit Lodge”), and San Cristobal Treatment Center, LLC, a Texas corporation (“San Cristobal Treatment”).
