REASSIGNMENT AND RELEASE OF SECURITY INTEREST

Assignor further agrees to execute and deliver to Assignee all further documents and instruments, and to do all further acts, which Assignee (or its agents or designees) reasonably requests, at Assignee's cost and expense, in order to confirm this Release and the Assignee's right, title, and interest in the Designated Trademarks.
