RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT

This **TRADEMARK RELEASE** is made as of May 17, 2019 (“Effective Date”) executed by **WHITE OAK HEALTHCARE FINANCE, LLC** (“Agent”), in favor of **ARGENTUM HOLDINGS, LLC** and **SILVERGATE PHARMACEUTICALS, INC.** (each a “Grantor” and collectively, the “Grantors”)

WHEREAS, the Agent wishes to terminate the Trademark Security Agreement and release, terminate and release any and all Liens, security interests and all of its right, title and interest in and to the Intellectual Property Collateral to the Grantors, including, without limitation, the trademarks set forth on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests or Liens it has and all of its right, title and interest in, to and under the Intellectual Property Collateral, whether now owned or hereafter created or acquired by each Grantor.
